The Stewards, having received a report from the Clerk of the Course, have considered the following matter and determine the following:

**Facts** The above addressed competitor requested the allocation of a new time on SS3 where

the crew was delayed by car No.16.

**Decision** The time of competitor No. 25 on SS3 is **not** amended.

**Reason** Between the split timing points at 9.4km and 15.51km competitor No. 25 stated that they had lost some time behind car No.16 on SS3, which had a damaged steering and was

therefore being driven slowly.

Having examined the report from the Clerk of the Course, the information provided by the competitor, the tracking data available and the split times set by competitors No. 21 and No. 25 on SS3 and having reviewed the on-board video from car No. 25, the Stewards conclude that the request for a correction of the time is not justified.

The Stewards do not consider the time loss in this case to be significant but merely due to a "racing incident" and therefore decide not to correct the time of competitor No. 25 on SS3.

The allocation of corrected or notional times is provided for in the WRC Sporting Regulations for certain cases which do, however, not specifically include a crew being delayed due to the above-mentioned circumstances.

With a view to sporting fairness in competitions and with reference to Art. 1.1.5 of the 2022 WRC Sporting Regulations, the Stewards may exercise their authority under Art. 11.9.2.a and Art. 11.9.3.j of the 2022 FIA International Sporting Code. The Stewards may decide that if the time loss is significant and cannot be considered as a 'racing incident', a corrected time can be implemented. However, competitors must be able to prove that it was extraordinary circumstances that led to any perceived time loss.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2022 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
