A VERY WARM WELCOME FROM THE ORGANISERS

Welcome to Rally Yorkshire 2022, which represents a unique opportunity for the whole rallying community to participate in a variety of events which use ALL of the CLASSIC YORKSHIRE STAGES. This year competitors in the Trackrod Rally Yorkshire will commence their competition, as is now traditional, **in Dalby Forest IN THE DARKNESS OF FRIDAY NIGHT.**

We are providing an extended rally of approximately 57 miles, of which 45 miles is SINGLE USE FOREST ROADS

For 2022 we are again pleased to be based in the town of Filey, thanks to the enthusiastic support of Filey Town Council, Filey Tourism & Trade Association and Scarborough Borough Council. Filey's Evron Centre will host the Rally Headquarters, with scrutineering facilities and the Service Park taking place at Filey Brigg Country Park. Friday evening sees the Ceremonial Start taking place on The Beach and the Ceremonial Finish on Saturday afternoon will also be there for all events.

Entries are via our on-line entry system as normal. However, for 2022, we are operating the following system: Regulations are available for viewing from Monday 1 August with entries opening on Friday 5 August at 19:00. At that point we only require an entry form (no payment), fully completed with all information. The entry portal will remain open until Sunday 7 August at 12:00 hrs. At that time the organisers will randomly select 150 entries (assuming we are experiencing high demand) and those entries will be emailed to acknowledge the entry and to request payment by Friday 12 August at 19:00 hrs. The organisers reserve 30 spaces to award at their discretion. Hopefully, this method will avoid "fastest fingers" or prejudicing those whose work patterns prevent them going on line when entries open OR experience delays in payments coming through. Entry fees are payable by credit/debit card - please see our website: www.rallyyorkshire.co.uk.



REGULATIONS

Article 1 Announcement

1.1 Trackrod Motor Club Limited (The Organisers) will promote:

A National Special Stage Rally – **Trackrod Rally Yorkshire** on Friday 23 September and Saturday 24 September 2022.

- **1.2** The event is a qualifying round of the following championship:
 - Motorsport UK British Rally Championship

(Motorsport UK Permit Number 2022/007)

Article 2 Jurisdiction

2.1 The meeting will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any other written instructions that the organising team may issue for the event.

Article 3 Authorisation

3.1 Motorsport UK Permit Number: 126627

3.2 DOE Authorisation Number: TBA

Article 4 Eligibility

- **4.1** The event is open to:
 - All holders of a National Stage Rally Competition Licence or higher.
 - Registered competitors in the Motorsport UK British Rally Championship.
- 4.2 The event has been inscribed on to the Motorsport UK 2022 National Competition with Authorised Foreign Participation (NCAFP) Calendar. Competitors from any one of the 27 EU (or comparable) countries holding a National Competition Licence issued by one of those countries may enter. The holder will be subject to Motorsport UK General Regulations whilst competing.
- 4.3 Competitors are reminded of the Motorsport UK's requirements for Entrants' Licences as laid down on the Licence declaration form and in the 2022 Motorsport UK's Yearbook. <u>All licences</u>, legal guardian letters of consent, championship documentation and applicable club cards will be inspected by electronic means through the on-line entries system.

Article 5 Format

5.1 The programme of the meeting will be as follows:

Monday 12 September 2022 (electronically for those entered by the first closing date).



6.2 Cars with forced induction will have their capacity increased by 70% to establish their class.

- 6.3 All cars must comply with current Motorsport UK Technical Regulations and, where appropriate, with FIA Technical Regulations (See also Article 12).
- **6.4** Competitors may enter only one class.

Article 7 Identification

- 7.1 Competitors must make space available to The Organisers, on both front doors, for Event (H 28.1.1) and, if applicable, Championship identification (H 28.1.2) as follows:
 - 1: The official Event logo/title on rally plates and panels
 - 2: Event rear rally plate
 - 3: Hi Viz numbers
 - 4: Competition numbers in accordance with J4 (Not WRC style plates)





- 7.2 Competitors will be identified by Rally Plates and Rally Panels, which will be provided by The Organisers, to be fixed to the rear of the car and to both front doors. In addition the event decals must be displayed on both sides of the car above the competition number. (Competition numbers will be the traditional size in accordance with J 4).
- **7.3** Competitors are reminded that Competition Numbers must be removed immediately upon retirement or after the event.
- **7.4** High visibility numbers will be supplied by The Organisers for fixing to the side windows behind the front doors.
- 7.5 All competitors are required to affix Event and Championship decals in the prescribed positions prior to presenting their cars for Scrutineering. Decals must be collected from the Filey Brigg Country Park, prior to entering Noise and Scrutineering.

Article 8 Entries

Regulations will be published on Monday 1 August 2022 with entries opening on Friday 5 August 2022 19:00 hrs. A fully completed entry form should then be submitted. No payment will be required at this point. On Sunday 7 August 2022, 12:00 hrs the entry application process will be paused, to assess the level of entries (up to a maximum of 180) and to admit 150 entries on a random basis. 30 spaces have been reserved for use at The Organisers' discretion. No communication will be entered into regarding these. The 150 entries will then be notified their entry has been acknowledged with a request for the entry fee to be paid by Friday 12 August 2022 19:00 hrs. Entries not making payment by this time will be removed and placed at the bottom of the Reserve list. Entries received, but not allocated a space in the initial pool of 180 entries will be allocated a reserve status on a random basis. Reserve entries subsequently offered a place in the main entry will have 3 days to make payment from the date of notification.

Depending on the level of entries received on Sunday 7 August 2022 at 12:00 hrs, if spaces permit, the entry system will re-open.

The first closing date is **on Saturday 10 September 2022 10:00 hrs.** The second and final closing date is **on Tuesday 20 September 2022 10:00 hrs.** PLEASE NOTE: DUE TO PRODUCTION DEADLINES, SEEDING WILL BE UNDERTAKEN AFTER THE FIRST CLOSING DATE. THOSE USING THE SECOND CLOSING DATE WILL NOT HAVE PREFERENTIAL SEEDING NUMBERS, OR APPEAR IN THE RALLY PROGRAMME OR ANY PRESS RELEASES. Entries received after the first closing date may be accepted at The Organisers' discretion and may be appropriately accommodated in the running order.

- 8.2 The maximum entry for the combined events (Trackrod Rally Yorkshire, Trackrod Historic Cup (incorporating the Trackrod Land Rover Challenge) & Trackrod Forest Stages) is 180 and the minimum entry is 100. The minimum for each class is 3. Should the minimum figures not be reached, The Organisers reserve the right to cancel the meeting, amalgamate classes or reduce the awards lists as deemed appropriate. They also reserve the right to reduce stage mileage should the minimum number of entries not be reached.
- **8.3** Entrants are required to indicate on their entry form their eligibility for the various Championships and Awards.
- 8.4 The order of starting will be at The Organisers' discretion (Article 22.2). To assist seeding, competitors should note their previous results on the Entry Form. A list of scheduled starting times will be posted on the Official Notice Board (virtual) on Friday 23 September 2022 at 13:00 hrs.
- **8.5** Competitors are advised that the information they provide will be stored in a computer retrieval system and may be used for organisational purposes.

The Organisers WILL MAKE A FULL REFUND (less £25.00 administration charge) of the entry fee to those competitors who, for reasons of 'force majeure' were unable to start in the rally and notified the Secretary of the Meeting no later than Thursday 22 September 2022 21:00 hrs.

- **8.10** The Secretary of the Meeting must be advised in writing at the Rally Office (Article 8.7) of any modifications to entries.
- **8.11** Subjective Route Notes are not supplied as part of The Organisers' documentation and must be purchased directly from suppliers detailed in Article 16.
- 8.12 Submission of an entry, online or otherwise, establishes a contract with Trackrod Motor Club Ltd and full payment must be made. Any competitor failing to make a full payment will be reported to Motorsport UK and their ASN for breach of contract.
- **8.13** Competitors are reminded of Motorsport UK's requirements for Entrant's Licences as laid down on the Licence declaration form and in the 2022 Motorsport UK Yearbook.

All licences, legal guardian letters of consent, championship documentation and applicable club cards will be inspected by electronic means through the on-line entries system. There will be a random physical check of licences of approximately 20% of the entry at Documentation Collection.

Article 10 Results

10.1 Interim times will be available via the links on The Official Notice Board (virtual) and the Sportity App – see Article 25.

Provisional results will be posted on the Official Notice Board (virtual) as soon as possible following the finish of the last car.

A query form is provided in the Road Book for competitors to complete if they have a query regarding the interim or provisional results. Provisional results will be declared FINAL after thirty minutes subject to the resolution of any protests, which must be made in accordance with the provisions of C 5.1 to C 5.7. and any technical checks. Instructions will be in the Roadbook as to the method of submission of any query.

Article 11 Route/Road Book/Documentation

- 11.1 Competitor Record Cards will be issued at Documentation Distribution, subject to both competitors having signed on. As required by R 2.3.2, these documents will comply with R 33 enabling competitors to comply with the requirements of the Motor Vehicle (Competitions and Trials) Regulations.
- 11.2 The Ceremonial Start will take place on Friday 23 September 2022, with the first car departing at 19:01hrs at The Beach, Filey, YO14 9LE. As space is limited on The Beach (road) competitors will be lined up in their start order. Competitors should drive down Ravine Road towards The Beach (road) 30 minutes before their due start time at MTC1. On Ravine Road there will be a pre-start Holding Area operated by marshals. Please park your car as directed by the marshals and wait either in, or close to your vehicle. It is anticipated that Sportraxx tracking units will be issued at this point.

When instructed by the marshals in the Holding Area, please drive down to The Beach and park as directed by the marshals. It is anticipated that competitors will drive down to The Beach in batches of approximately 20 vehicles. Approximately five minutes before your due start time you will be asked to drive towards MTC1.

Toilet facilities are available on The Promenade (just below MTC1 on The Beach) if required.

The rally will start from The Beach, Filey. YO14 9LE. Cars will start at one minute intervals. Any competitor not signed on thirty minutes before their due start time may not be allowed to start.

On Saturday 24th September, the Restart will take place at Bridestones, Dalby Forest, MR. 101/878905; with the first car departing at at 08.46hrs. There is no pre start holding control. **Competitors are requested to NOT arrive more than 15 minutes before their MTC3 due start time.**

Competitor's cars ONLY at the Restart. **STRICTLY NO TRAILERS OR UNLOADING ON THE FOREST DRIVE OR APPROACH ROAD FROM EBBERSTON.**

The rally will finish at The Beach, Filey, YO14 9LE.

11.3 The event will contain Special Stages on Forestry Commission land linked together by road sections on public and private roads as follows:

- 11.4 Competitors will be supplied with a detailed 'Tulip' Road Book which will be made available in hard copy at Documentation Distribution. An electronic copy will be emailed to the nominated contact on Monday 12 September 2022.
- 11.5 The rally route will be contained on the following Ordnance Survey map sheets: Landranger - 1:50 000 Sheet Numbers 94, 100 & 101
- 11.6 The Organisers may establish checks along the route in accordance with R 2.3.3.
- 11.7 The Sporttraxx UK tracking system will be utilised by the event.
- 11.8 There will be NO Parc Fermé on either Friday 23 September 2022 or Saturday 24 September 2022.

Article 12 Scrutineering and Documentation

- 12.1 Scrutineering will be held on Friday 23 September 2022 between 13:00 hrs and 17:30 hrs at Filey Brigg Country Park. Before proceeding to Scrutineering, competitors must first report to the Noise Test Control, which will be open between 13:00 hrs and 17:30 hrs at Filey Brigg Country Park. Competing cars may be held at the Noise Test Control to avoid congestion at Scrutineering.
- 12.2 At Scrutineering, cars will be examined for compliance with the current Motorsport UK Tyre, Technical and Safety Regulations as well as for Class and Award eligibility. Each entrant and driver will be assumed to have full knowledge of the car and its eligibility for the class entered.
- 12.3 A Competition Car Log Book must be made available for each car at Scrutineering and on demand throughout the event. Failure to produce this document will lead to a refused start or disqualification (R 46.1.3). Additionally relevant homologation paperwork must be presented.
- 12.4 No competing car may carry more than one physically disabled person, whose participation in the competition must be approved by Motorsport UK. The FIA Non-Ambulant Logo should be affixed on both sides of the vehicle. Specific restrictions may apply (H 12).
- 12.5 A valid MOT Test Certificate must be produced at Scrutineering on request for any car required by law to have such a certificate. Failure to produce this certificate will lead to a refused start (R 46.1.2).
- 12.6 All cars shall have Fire Extinguishing Systems conforming to the 2022 Motorsport UK requirements (K3). Crash helmets and FHR devices will be examined for conformity with current regulations (K 10) and must be worn on Special Stages (R 25.3.1 & R 25.3.3).
- 12.7 Cars shall have fitted, and the driver and co-driver shall use, seat belts in conformity with K 2 and R 25.3.1.
- **12.8** Drivers and co-drivers are reminded that they must wear flame-resistant overalls on all Special Stage Rallies and the wearing of a face covering and/or balaclava is advisable. (K 9 and R 25.3.2).

- **12.9** On board cameras may be carried subject to J 5.21.
- 12.10 Judges of Fact and/or Driving Standards Observers will be appointed to report on sound levels. Excessive sound will include instantaneous occurrence of noise such as that produced by backfiring caused by anti-lag systems. The penalty for excessive sound may go as far as disqualification.

12.11 Fuel

VP Racing Fuels will be in attendance in the Refuelling Area at Filey Brigg Country Park to supply VP R5.1 and RX102 on Friday 23 September 2022 and in the Refuelling Area at Adderstone on Saturday 24 September 2022 during the event. Fuel must be pre-ordered by contacting VP Racing Fuels on 02476 717100 or by email racefuel@oldhallperformance.com.

Competitors are strongly requested to take advantage of this professional refuelling service and avoid the risk associated with service crews carrying large quantities of fuel to the event.

The onus is on the competitor to order their fuel from the suppliers. The Event Organisers will not be involved in this process in any way.

Competitors not utilizing the recommended fuel supplier may refuel in the normal way in the Service Area. Competitors are only permitted to use fuel that complies with the definition of 'pump fuel' as in the 2022 Motorsport UK Year Book. There must be no occupants in the rally car at any time whilst it is being refuelled.

Also, fuel will be available at limited commercial filling stations on or close to the road route, mainly in Pickering but also in East Ayton and Middleton. Competitors must not refuel their vehicles elsewhere.

12.12 All cars must carry an environmental Spill Kit. The presence of these kits will be checked at Scrutineering, and any crew not in possession of a kit will be refused a start. Failure to carry a Spill Kit during the event will be penalised by disqualification.

Article 13 Damage Declaration

- 13.1 Competitors will be required to complete and sign a damage declaration which will be included within the Competitor Record Card, declaring whether they have been involved in any incidents resulting in damage to private property and/or injury to persons or animals, or alternatively giving details of any such incident where damage or injury has occurred (R15.1.2). Any information given will not incur a penalty, but failure to submit a duly completed form online will be penalised by disqualification and may be reported to Motorsport UK for further disciplinary action. The competitor is responsible for the payment of any insurance excess up to a maximum of £425 levied upon The Organisers as a result of any claim by a third party. This signed declaration must be deposited in the box at MTC6.
- 13.2 Competitors who do not report to the finish of the event are required to forward the report to the Secretary of the Meeting at the Rally Office (Article 8.7) within 72 hours of the finish of the event (R 15.1.3).
- 13.3 If competitors have been involved in an incident they must supply full details to The Organisers on the days of the rally. Competitors who fail to comply will be penalised in accordance with R 15.1.2 and may be reported to Motorsport UK for further disciplinary action.

Article 14 Driving Standards Observers/Judges of Fact

- **14.1** Named Judges of Fact, appointed by The Organisers, will be on duty throughout the rally to observe and report upon any competitor considered to be in contravention of R 24.7, and R 25.6.
- **14.2** Scrutineers appointed for the event are Judges of Fact in respect of vehicle eligibility.
- 14.3 Start Line Officials on all Special Stages will be empowered to judge whether or not any competitor has made a false start.

- 14.4 The Organisers will appoint Driving Standards Observers in accordance with G11 and R 24.8.
- Any notified offence, by a competitor or by their service crew, which involves speeding, reckless driving or failing to observe road signs will automatically be considered as a possible contravention of C 1.1.4. The competitor concerned is liable to be penalised in accordance with R 32.2(k), R 32.2(l) and R 38.3.1.

Article 15 Controls and Timing

- 15.1 Timing of the event will be governed by the Target Timing regulations (R 31.1- R 32.1.3), using Digital clocks operated by officials under the control of a Motorsport UK Approved Timekeeper. Road timing will be to the previous whole minute and special stages to 1/10th second.
- **15.2** Maximum permitted lateness will be 15 minutes between MTC's (R 31.2.5). This will be penalty free (R 31.2.6).
- 15.3 The event will be using "limited contact timekeeping". Your Competitor Record Card will be for your own use. It is not to be handed to marshals. Event results will be compiled from times transmitted automatically by the clocks and from photographs of marshals' check sheets uploaded to the results services. Additionally, there will be Passage Checks where the marshal will transcribe the times from your Competitor Record Card. The Organisers may use any means at their disposal to establish a time.
- 15.4 For ALL special stages, automatic start timing will be used, in accordance with R 25.7.2. The start will be signalled by start lights which will go from RED (15 seconds to GO) through AMBER (5,4,3,2,1) finally to GREEN at the start time. In the event of equipment failure, the start procedure will revert to the manual system (R 25.7.1).

Special stage finishes will be timed to the previous 1/10th of a second (R 26.5.1) and road sections timed to the previous whole minute (R 31.1.3).

Competitors are referred to R 24.5 for details of penalties which may be awarded in the event of a special stage being stopped.

Should any special stage be cancelled during the event or removed from the results after the event, only the Stage Penalties will be deleted. Unless an Official Bulletin has been issued to the contrary, the cancelled stage must be traversed within Target Time, and will in every other respect be treated as a road section.

15.5 REGROUP CONTROLS

The Road Book will specify these controls, where competitors not disqualified by having more than the maximum permitted lateness at that control, will start the next section with zero lateness (R 31.2.10).

15.6 EARLY CHECK-IN AT THE END OF DAY

At the end of a day, competitors are allowed to check in at the final Time Control, in advance of their due time (R 30.3.3). Competitors that arrive early must have their due time recorded on the check sheet and on their Competitor Record Card; those arriving later than their due time must have their actual time of arrival recorded on the check sheet and on their Competitor Record Card.

15.7 MISSING A CONTROL OR STAGE & RE-STARTS

Any crew which has retired from Day 1 may re-start the rally from the start of Day 2. R40.1.6 and R40.1.7 apply. The only re-join point is MTC3 (Saturday Restart).

Competitors not completing Day 1 (Friday) may restart Day 2 (Saturday). It will be assumed that competitors will re-start Day 2. If the crew does not wish to re-start, the form declaring retirement must be completed and lodged with the Secretary of the Meeting as soon as possible before Day 2.

The retirement form/ damage declaration forms are included within the Competitor Record Card.

In accordance with R32.2 (a) (i) a crew not completing or missing SS1 will incur a penalty of 15 minutes plus the stage maximum for the stage missed. Should retirement occur after the special stage of Day 1, the crew will nonetheless be deemed to have missed that special stage.

Competitors re-joining Day 2 MUST present their cars to the scrutineer at MTC3, on Saturday between 07.45 hrs and 08:30 hrs. The car must retain its original shell and engine block as marked at pre-event scrutineering or recorded on the record card and retain the same crew.

Any crew which has retired from the final day will not be classed as a finisher.

Article 16 Reconnaissance and Subjective Route Notes

16.1 Reconnaissance for Trackrod Rally Yorkshire

16.1.1 Procedures for Registration

Competitors must record in the appropriate place on the entry form that it is their intention to take part in the reconnaissance. Administrative checks for competitors taking part in the Reconnaissance will take place at the start of reconnaissance,

- 16.1.2 Reconnaissance will provisionally start on Friday 23 September 2022 at TBC at Adderstone and will run as a convoy. Competitors should sign on by TBC and receive hard copies of road books at the start of Reconnaissance at Adderstone (These arrangements will be confirmed in Bulletin1/Final Instructions). The first fifteen cars will run in seeded order with the remainder running in order of arrival. On arrival at the first stage competitors should park in such a way as to allow cars seeded in the top fifteen past if necessary. There will be official cars displaying orange flashing lights spaced roughly every ten cars; these will all be in radio contact and must not be overtaken unless competitors are instructed to do so. There will be a recovery vehicle at the tail of the convoy.
- 16.1.3 A Road Book covering the reconnaissance road sections will be issued with the Road Book. The Organisers strongly advise competitors to check with their Insurers that they have valid insurance cover to take part in the Reconnaissance. The Organisers will also take details of the reconnaissance vehicle. The Organisers may at the discretion and with the agreement of the Stewards of the Meeting refuse a start to any competitor who is found to have carried out unauthorised practice or reconnaissance over the route of any Special Stage. Those living on a Special Stage, or who may have cause to drive along a Special Stage for whatever reason, should inform The Organisers in advance.

16.1.4 Reconnaissance Cars

Common requirements:

- The car must be painted in a single colour, with no advertising, stickers, etc.
- Underbody protection is authorised (complying with the Group N regulations).
- Two additional road-homologated headlamps are authorised.
- The crew may use a "light" intercommunication system (without helmets).
- On board navigation equipment may be fitted.
- Cars which conform to the following specifications may be used:

Standard Cars

Totally unmodified standard cars as offered for sale to the general public.

Production Cars

- The engine shall be a series production engine (complying with the Group N regulations).
- The gearbox shall be a series production gearbox (complying with the Group N regulations).
- The exhaust shall be a series production exhaust with a maximum noise level within the permitted legal tolerances of the organising country.
- Suspensions shall comply with the Group N regulations.
- The fitting of a steel safety rollbar complying with Articles 253-8.1 of Appendix J is authorised.
- Bucket seats in colours similar to those of the interior of the car are authorised.
- The rims are free within the limits of Appendix J Article 254.

Any competitors using a vehicle not complying with the regulations may be fined £500 as infringement of Article 16.1.4 or be excluded from completing the reconnaissance.

16.1.5 Tyres for Reconnaissance Cars

Tyres used for reconnaissance shall be:

- Road-homologated series production tyres for asphalt.
- Tyres for gravel must comply with Motorsport UK List 6 or be road tyres.

It is strongly recommended to carry at least two spare wheels and tyres. Space savers are not recommended.

16.1.6 Reconnaissance identification plates as supplied by The Organisers must be affixed to both rear side windows on the registered vehicle prior to starting the reconnaissance. Failure to do so will be deemed to be a breach of the reconnaissance regulations.

There will be a speed limit of 30 mph (48 km/h) on Special Stages during reconnaissance. Judges of fact will be appointed to check speeds at random locations and supervision vehicles will be patrolling in stage. Competitors found to be speeding while travelling through the stage will be deemed to have committed a second infringement.

Vehicles will be allowed to traverse the stage in start order but there will be a minimum of 20 second intervals applied to vehicles entering stage. Competitors who stop or impede other competitors, in the opinion of The Organisers, during the reconnaissance will be deemed to be in breach of the reconnaissance regulations. Each vehicle and competitors will only be allowed to traverse any stage twice.

Competitors are reminded that during the reconnaissance period the road used for special stages will be open to other traffic or pedestrians and that forestry operations may be in progress in certain areas.

The carrying of radar detection equipment in the reconnaissance vehicle is forbidden during the entire duration of the reconnaissance.

16.1.7 The penalties for contravention of the supplementary regulations regarding reconnaissance are as follows:

First Infringement £100 Second Infringement £500

Third Infringement Start Refused

Notification of penalties will be made to the competitor at the earliest opportunity. All monetary fines must be paid in full before any competitor will be allowed to start the rally.

Only the registered members of the crew may be in the reconnaissance vehicle when traversing the stage.

- 16.2 The possession of pace notes, as defined in R 25.9, by a competitor during the course of the rally, whether or not they relate to the stages being used on the rally, is permitted, including the use of Ordnance Survey Maps specified in the regulations as being necessary to complete the route.
- 16.3 Practice, reconnaissance or the use of pace notes is permitted, but subjective route notes purchased from the approved suppliers may be used. These instructions will not be defined as Pace Notes. Contact:





Information from the Road Book or the Official Bulletins may be transferred to and from the authorised maps listed in these Regulations. A Logging/Update Information Sheet containing last minute changes, logging information on the stages and any additional information will be displayed on the Official Notice Board (virtual).

Article 17 Servicing

17.1 There will be one service area at Filey Brigg Country Park and this is the only service area during the event. Details of the location will be published in the Final Instructions and the Road Book. No other areas may be used for service and will therefore be "out of bounds" to service personnel and vehicles.

Servicing is defined as work being carried out on the car by any person other than the competing crew. or the use of any part or tool not carried in the competing car (R 38.1). Servicing will only be permitted by an official service vehicle, identified by an official plate, in the Service Area, which is visited between SS4 & SS5. The entry fee includes a standard service plate corresponding with a standard service bay of 6m x 6m, adequate for a service vehicle up to 3.5tonne GVW. As space within the Service Area is at a premium, if a larger vehicle, i.e. over 3.5tonne GVW, or a motorhome is to be used for servicing, then a larger service bay of 10m x 6m must be ordered for an additional charge of £50.00. For those requiring a larger space than the 10m x 6m, a Custom Bay is available for a charge of £250.00. Requests for a Custom Bay service plate must be directed to the Entries Secretary.

Although there is only one central Service Area at Filey Brigg Country Park, competitors and their service crews will additionally be permitted to service their vehicles there any time before MTC1 and IF THEY CHOOSE TO RETURN TO FILEY ON FRIDAY EVENING after MTC2 and before MTC3. It should be noted that there will be NO toilets and lighting overnight. It should also be noted that there is no camping permitted on Friday night in the Service Area under instruction from Scarborough **Borough Council.**

Competitors are reminded that the Service Area is a NON SMOKING area and additionally, consideration must be shown to local residents and therefore engines MUST NOT be run between Friday 23 September 2022, 23:00 hrs to Saturday 24 September 2022, 07:00 hrs.

Filey Brigg County Park Service Area Opening times:

Friday 11:00 hrs - 22:00 hrs Saturday 07:30 hrs - 18:00 hrs

- 17.2 Crews may work unassisted on their own cars, using equipment carried in their car, in 'No Service' Areas, except:
 - within 100 metres of any Control.
 - between a Special Stage Arrival Control and a Special Stage Start Control.
 - in any Parc Fermé.

The only work permitted in these areas is the following unassisted:

 cleaning lamp glasses, windscreens, windows, identification markings and vehicle registration numbers.

When servicing is prohibited:

The use or receipt by the competing crew of any manufactured materials (solid or liquid), spare parts, tools or equipment other than those carried in the competing car, is forbidden.

- 17.3 Service crews will be subject to the same regulations as competitors regarding noise and driving manners and Judges of Fact/Driving Standards Observers will be instructed to note any infringements. Competitors are responsible for ensuring that their service crews understand and comply with this Regulation. Any verbal or physical abuse towards any Rally Officials by service crews may result in the disqualification of the competing crew.
- 17.4 Service vehicles must park as directed by marshals at the Service Area. Failure to comply will result in penalties which may go as far as disqualification.
- 17.5 Each service vehicle must be registered with The Organisers by its vehicle registration number, which must be submitted on the appropriate form by Tuesday 20 September 2022,10:00 hrs.

An official plate will be issued for each vehicle. This plate must be affixed to the bonnet or exterior surface of the windscreen of the vehicle in clear view prior to entering the Service Area. It is not sufficient to leave the service plate lying on the dashboard. Access to the service area will only be for competitors and their service vehicle bearing an official plate.

The use of a Service Plate on a vehicle not previously registered with The Organisers is an offence for which a penalty will be applied. N.B. The ONLY vehicles allowed in the Service Area will be competing car and ONE service vehicle. Security personnel will be on duty to assist and will enforce this regulation. N.B.no additional service vehicles will be permitted into the Service Area.

Additional vehicles can be parked in the adjoining Northern Council Car Park adjacent to the Service Area. Two car park passes will be issued to each competing crew to enable them to park there free of charge for the duration of the event. 1 additional car park pass will be given to each crew at the start of Reconnaissance. Any additional vehicles will be subject to Scarborough Council's normal charges and terms and conditions. See

<u>Country Park car park | SCARBOROUGH.GOV.UK</u> for details of charges and terms and conditions that will apply.

Traffic Enforcement Officers will be in attendance throughout the event and vehicles not displaying a Pass or not paying the appropriate fee for parking will be fined in accordance with the local By-Laws.

Please note that CCTV will be in operation throughout the event in the Service Area to ensure that only vehicles displaying a Service Pass or Competing Cars have access to the Service Area, and to ensure the safety of the marshals.

17.6 All competitors must use a tarpaulin sheet under the car they are servicing or working on. Failure to comply will be penalised by a time penalty of 10 minutes for the first offence, a time penalty of 20 minutes for the second offence and disqualification for a third offence. Servicing of vehicles will be on a mix of grass and loose hard standing surface.

- 17.7 The use of helicopters or light aircraft by any competitor or persons associated with any competitor over the route or stages used during the duration of this event is prohibited. Breach of this regulation will be penalised by disqualification and offending competitors will be reported to Motorsport UK in accordance with R 39.3.
- 17.8 The area to park trailers is away from Filey Brigg Country Park, where Service Plates will be available for collection see Article 5 for details. The Organisers are not responsible for loss of, or damage to, any trailer left in the trailer park. When approaching from the west along the B1261 continue past the entrance to the Trailer Park (on your right) to the roundabout and then double back turning LEFT into the Park. This will avoid vehicles turning right into the Trailer Park and hopefully reduce any traffic congestion on this busy road.

Trailers MUST NOT be taken to Filey Brigg Country Park.

All Service Vehicles with the exception of **Custom Service Vehicles** must pass through the Trailer Park to have their Service Plate attached to their vehicle. Access to the Service Area will be denied if there is no visible Service Plate attached to the vehicle. Entrants/Competitors who have purchased a **Custom Service Vehicle Plate** MUST contact the Entries Secretary prior to 20 September and make arrangements for the issue of their Service Plate.

Service vehicles must park as directed on entering the Filey Brigg Country Park, which will be indicated in the Final Instructions and the Road Book, on Friday 23 September 2022 between 11:00 hrs- 22:00 hrs and on Saturday 24 September 2022 between 07:30 hrs – 18.00 hrs. Failure to comply will result in penalties which may go as far as disqualification.

- 17.9 Cars must be fitted with towing eyes at front and rear (R 48.1.13) to allow recovery by official licensed vehicles. Recovery vehicles will only tow competition cars as far as the forest exit, as the terms of their insurance do not permit towing on the public highway. From this point onwards, recovery is the responsibility of competitors and their service crews.
- 17.10 Emergency servicing will not be permitted. THAT MEANS NO CHASE, MANAGEMENT OR AUXILIARY VEHICLES WILL BE ALLOWED SERVICE OBSERVERS WILL BE PATROLLING THE ROUTE TO ENSURE THIS IS ADHERED TO. PENALTY FOR CONTRAVENING THIS ARTICLE IS DISQUALIFICATION.

Article 18 Penalties

- 18.1 Competitors will start with zero time penalties. The results will be established by adding together the times taken during the special stages and the time penalties incurred on the road sections together with all other penalties expressed in time. The competitor with the lowest total will be the winner and so on (R 40.1.1).
- 18.2 If there is a tie, the competitor who accomplished the best time for the first special stage will be proclaimed the winner. If this is not sufficient to be able to decide between the tied competitors, the times of the second, third, fourth, etc., Special Stages will be taken into consideration (R 40.1.2).
- **18.3** The penalties in R 32.2 Chart 32.2 Penalties will apply unless specifically modified in these SRs.
- 18.4 It is at the discretion of an Environmental Scrutineer, a Judge of Fact or The Organisers whether a car which causes excessive sound is REFUSED A START/REFUSED PERMISSION TO PROCEED/or DISQUALIFIED at any time (R 4.1).
- A Driving Standards Observer's report which results in the imposition of a penalty for excess speed or bringing the sport into disrepute will also be reported to the Stewards of the Meeting (R32.2 Chart 32.2 Penalties (I)).
- 18.6 Lateness in excess of Target Time on road sections and Stage Maximum Time on special stages is cumulative. The maximum penalty free lateness will be 15 minutes (R 31.2.5 & R 31.2.6). Once a competitor's cumulative lateness calculated from the previous Main Control exceeds the maximum penalty-free lateness, the competitor will be deemed to have RETIRED.

Article 19 Awards

19.1 GENERAL CLASSIFICATION (All awards to be won outright with the exception of the overall awards):

Trackrod Rally Yorkshire

1st OverallAward to driver and co-driver2nd OverallAward to driver and co-driver3rd OverallAward to driver and co-driver

19.2 CLASS AWARDS:

Awards for 1st, 2nd, & 3rd in each class (subject to 3, 5, 8 entries) Award to Driver & Co-Driver

(Winners of overall awards are ineligible for class awards)

19.3 OTHER TROPHIES AND AWARDS:

TRACKROD RALLY YORKSHIRE SOUVENIRS will be awarded to the crew of every car which finishes the rally.

- 19.4 Competitors wishing to compete for particular awards other than the General Classification, Group and Class awards must claim for such awards on the entry form. The Organisers shall have absolute discretion to accept or reject any such claim and in cases of doubt may call for proof in support of any claim.
- 19.5 Results and awards will be provisional until all parties have had the opportunity to protest and appeal as per Article SR10.2 and MSUK GR H34.1.5 34.1.7 requirements are completed.
- 19.6 All awards will be posted to competitors after the event. Please note that the awards may be despatched directly from the supplier and consequently the event will therefore share the address and phone contact details of the named contact on the entry form for all award winners to enable despatch to take place. However, all competitors finishing the event will receive a souvenir finishers award.

Article 20 Insurance

- 20.1 Vehicles must have Insurance in place which provides Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover as an adjunct to an existing motor policy.
- 20.2 If a competitor uses an extension to an existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.
- **20.3** If a competitor wishes purchase additional cover via The Organisers, then they can do so prior to the event providing they comply with the following.

Age 19 years or over

Has held a full licence for a minimum of 6 months

Has no more than 6 points on their licence

Has had no more than 1 fault claim in the last 3 years

The vehicle has valid Tax, MOT and is currently insured for road use

20.4 Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

- 20.5 Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from Reis Motorsport Insurance has been obtained by the event organisers, prior to the event.
- 20.6 Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded, disqualified or retire from the event.
- **20.7** The Event Organiser's RTA scheme is provided by Reis Motorsport Insurance and underwritten by Markerstudy Insurance Services Limited.
- 20.8 Reis Motorsport Insurance is a trading name of the Insurance Factory Limited. Insurance Factory Limited is authorised and regulated by the Financial Conduct Authority (No 306164). Registered in England and Wales number 02982445 at 45 Westerham Road, Bessels Green, Sevenoaks, Kent, TN13 2QB.
- **20.9** Markerstudy Insurance Services Limited registered in England and Wales (No 2135730) is authorised and regulated by the Financial Conduct Authority (No 475572)
- 20.10 Competitors will be required to sign the declarations as detailed in D 13.1. D.13.1.4 and D 13.1.5

Article 21 Medical Assistance (R 25.4)

21.1 Competitors are reminded of the requirements of R 25.4 with regard to the use of SOS/OK boards and act accordingly.

Article 22 Seeding

- **22.1** Competitors should list their driver's best five results **on stage events after 1 January 2019** on the entry form to assist with seeding.
- **22.2** The starting order for stages on Friday 23 September 2022 will be:

All Historic cars will run at the head of the field in reverse order of anticipated performance, followed by all Trackrod Rally Yorkshire cars in order of anticipated performance and then the Trackrod Land Rover Challenge.

Entries for the Trackrod Historic Cup, Trackrod Rally Yorkshire and Trackrod Land Rover Challenge will be amalgamated with the entries for the Trackrod Forest Rally on Saturday 24 September 2022.

The starting order for stages on Saturday 24 September 2022 will be:

ALL the 2WD drive competitors together with any Historic 4WD cars will run first on the road (together with competitors from the Trackrod Historic Cup). These competitors will run in reverse order of anticipated performance. The remainder of the field including <u>all Trackrod Rally Yorkshire</u> competitors, will then run in order of anticipated performance followed by the Trackrod Land Rover Challenge

Article 23 Radio Equipment

The use of radio transmitting and receiving equipment in competing cars and/or service vehicles is not prohibited under the regulations for the event, but the competitors are reminded of R 25.1 and that radio checks will be carried out in conjunction with the Police on competitors' and service vehicles

It is wise for foreign competitors to investigate the possibility of hiring radios which comply with the U.K. Government regulations. Those companies that hire out radios also undertake the licensing of the equipment. Information on the frequencies permitted can be obtained from any radio telephone hire company and from the address below. Ofcom should be contacted for assistance for those competitors contemplating long term licensing.

The Sportity app will be the primary route for the issue/notification of rally documents (e.g., start and restart lists, bulletins and on-event information). As a result, it is important that the crew have access to the app and that support members of the team are also encouraged to arrange access.
