## I. INTRODUCTION.

## 1.1. "Rally Elektrenai by aromama 2022" is organized following:

-Lithuanian Automobile Sporting Code and its appendices;

-2022 Lithuanian Automobile Rally Sporting Regulations (further – T-2022);

-2022 Lithuanian Automobile Rally Championship (further – LARC) Regulations;

-2022 Lithuanian Automobile Rally Sprint Championship (further – LARSC) Regulations;

-These Supplementary Regulations and its' Bulletins.

Changes to these Supplementary Regulations will be announced to all crews only by numbered and dated Bulletins issued by Organiser or Stewards. The Supplementary Regulations are published in Lithuanian and English. In case of disagreement about interpretation of these regulations only English text will be binding.

## IV. ENTRIES.

## 4.1. CLOSING DATE FOR ENTRIES:

Closing date for entries: 26<sup>sh</sup> of August, 2022 (Friday) at 18:00.

Closing date for entries with increased fee  $2^{nd}$  of September, 2022 (Friday) at 18:00.



## 4.2. ENTRY PROCEDURE:

Competitors may enter the event using the on-line entry system which can be accessed via <u>www.autorally.lt</u>. The entry has to reach organizer by the terms indicated in an article 4.1. Entry is considered as received when the participants appear in an entry list at autorally.lt. They are published when the entry fee is paid and received.

**Fully filled and signed entry form must be provided to an organizer during administrative checks**. Information about 2<sup>nd</sup> driver could be provided during Administrative Checks.

IMPORTANT: seeking to avoid hustle during the Administrative checks, as well as willing to speed up the procedures, we ask to send needed documents (scanned, pictured) over one email to <u>info@rallyelektrenai.lt</u>.

Alternatively, a Competitor may send fully completed entry form over the email to: info@rallyelektrenai.lt.

## 4.3. NUMBER OF COMPETITORS ACCEPTED AND CLASSES:

**4.3.1. Maximum number.** The maximum number of entries accepted will be 95. If more than 95 entries are received, the Organiser reserves the sole right to decide which entries will be accepted.

#### **4.3.2.** Cars eligible to enter the event.

Cars complying with LARC Regulations Art.4 are eligible to enter LARC.

Cars complying with LARSC Regulations Art. 5 are eligible to enter LARSC.

Other cars corresponding to 2022 FIA Appendix J safety requirements are allowed to participate in "Rally Elektrénai by aromáma 2022" overall and 2WD classifications.

2021 year LARSC, LMRC classifications' winners, who haven't participated in LARC before, and start participating in LARC classifications, entry fee is 250 EUR (increased entry fee is



375 EUR). Winners are considered as 1<sup>st</sup> and 2<sup>nd</sup> drivers, who won the 1<sup>st</sup> place in LARSC classifications. If these 1<sup>st</sup> and 2<sup>nd</sup> drivers are starting in different crews and different classifications, reduced entry fee rule is applicable to the both teams. If it is "junior" classification's winner, lower entry fee is applicable only to 1<sup>st</sup> driver's crew. LARC Team entry fee 70 EUR.

"0" crews willing to participate in rally, must pay a 250 EUR deposit until 9<sup>th</sup> of September, 2022 (Friday) 10:00 (details for bank transfer are provided in 4.5. article). The mentioned deposit is returned in that case, if the crew has performed a qualitative run during the rally and has fulfilled the tasks and functions trusted to the crew.

During "Rally Elektrenai by aromáma 2022" there will not be a Shakedown and Gravel Crews.

It is possible to pay entry fee during the Administrative Check with separate Organisers' permit only.

## 4.6. REFUNDS:

Entry fee will be refunded:

In case rally does not take place due to fault of the Organiser - 100%;

To candidates whose entry has not been accepted - 100%;

In case of the rally does not take place due to force majeure – 50 %;

If the participant can't participate due to force majeure acknowledged by ASN - 50%.

## V. INSURANCE.

## 5.1. INSURANCE COVERAGE FOR THE ORGANISER:

## 5.1.1. Organiser's Liability Insurance.

Organiser has concluded an insurance contract with Organiser's liability insurance covering damage caused to a third party during the competition up to 58000 EUR. The insurance period is from 9<sup>th</sup> of September 00:00 h until 10<sup>th</sup> of September, 2022, 23:59 h.

## 5.1.2. Damage Caused to the Third Party.

A part of insurance contract is coverage for damages caused to the third party. However, damages caused by drivers among themselves are not covered by contract.

## 5.1.3. International Green Card.



All crews at Administrative Check have to hand in a valid motor third party liability insurance policy or International Green card for their car. Without these cards, the crew will not be permitted to start.

## 5.2. INSURANCE COVERAGE FOR COMPETITORS AND CREWS:

All drivers and co-drivers are obliged to arrange their own life accident insurance. The proof should be documented on request at administrative checking.

By the fact of signing entry form, competitors and/or drivers relinquish any claims to compensation of any kind which might result due to incidents. The relinquishment is applied to FIA, ASN and Organiser, officials and other competitors and/or drivers. Drivers and co-drivers from non-EU countries have to have valid travel insurance contracts with active recreational risks included.

## 5.3. DAMAGE REPORTING:

Crews are obliged to notify Organiser about any damage caused on track by their car by the end of event the latest. Violation of this duty will be penalized by 100 EUR.

## 5.4. INSURANCE COVERAGE EXCLUSIONS:

Auxiliary vehicles, reconnaissance cars and vehicles with special stickers issued by the organiser are not covered by the provided rally insurance (with the exception of insured Organiser's cars) and those are always going on their own responsibility.

## 5.5. DAMAGE COVERAGE EXCLUSIONS:

The Organiser refuses any liability for damage that has been caused by a participant due to unfair action – either regarding rally regulations or these Supplementary Regulations or the State Law. In case of a road traffic accident neither a service car, reconnaissance car nor official's car with rally markings are considered as crew of the competition. In these cases only a car owner third-person liability insurance policies are valid.

## VI. ADVERTISING AND IDENTIFICATION.

## 6.1. COMPETITION NUMBERS AND ADVERTISING:



Prior to the pre-start scrutineering starting numbers, rally plates and Organiser's advertising should be affixed on the rally car according to Appendix 4.

## 6.2. LOSS OR REMOVAL OF COMPETITION NUMERS AND ADVERTISING:

Failure to comply with any regulations concerning the plates and identification numbers will be brought up to the Stewards.

#### VII. TYRES.

#### 7.1. NUMBER OF TYRES AND ELIGIBLE TYRES:

#### 7.1.1. LARC:

Number of tyres. The number of tyres for the event is limited to - 8. <u>Tyres used on</u> <u>SS 1A/1B are not included in the tyre count.</u>

**7.1.2. Allowed tyres.** All crews, participating in rally, must act accordingly to 2022 LARC regulations appendix no. 13.

#### 7.2. TYRES USED FOR RECONNAISSANCE:

Only E- or DOT-approved road homologated tyres are allowed. Retreated tyres are forbidden for reconnaissance. Any treatment (i.e. Removing or damaging) on road tyres side markings or texts is not allowed.

#### VIII. FUEL.

#### **8.1. FUEL RESTRICTIONS:**

It is allowed to use commercial fuel that is sold in retail, E85 fuel (bioethanol).

#### 8.2. REFUELLING:

8.2.1. All Competitors may only refuel in a Refuelling Zone (RZ). There will be a Refuelling Zone marked in the Road Book after the exit TC from the Regrouping area in Elektrenai.

8.2.2. Refuelling at the exit of the Regrouping area. Competitors' cars may be refuelled from drums/cans with commercially available fuel and two team members with team passes may access the RZ to assist each crew.



8.2.3. Refuelling procedure. Only crew members and support personnel are responsible for compliance with fire safety regulations during the refuelling. Liquid proof mat has to be used. Refuelling procedure must be followed as it is indicated in T-2022 article 61.2. Otherwise, crew might be penalized by Stewards.

## IX. RECONNAISSANCE.

## 9.1. PROCEDURE FOR REGISTRATION:

Reconnaissance registration will take place at the same time with administrative checks as follows:

9<sup>th</sup> of September, 2022 (Friday) 7:00 – 10:00. Elektrėnai Culture Center, Draugystės st. 2, Elektrėnai. Coordinates: 54.782857, 24.659974

## 9.1.1. Checking of Reconnaissance cars.

Reconnaissance cars will be checked during reconnaissance. Reconnaissance cars must comply with Article 35.1 of T-2022. If, for any reason, a crew is forced to replace the reconnaissance car during the reconnaissance, the Secretariat (phone: +370-686-85146) must be informed about the details of the new reconnaissance car.

## 9.2. NATIONAL SPEED LIMITS:

## 9.2.1. Speed during reconnaissance.

All reconnaissance of Special Stages has to be done at reasonable speed in accordance with Lithuanian traffic rules. The maximum speed set for reconnaissance of SS is 70 km/h, except for those areas in which there are speed limit signs (50 km/h or 30km/h) or other limitations marked in the Road Book. Breaking the rules and exceeding speed limits on public roads will be also



controlled and fined by the Lithuanian Police according to traffic laws of Lithuania. **GPS data will also be monitored during liaison.** 

## 9.3. GPS SPEED CONTROL CHECKING DEVICES:

9.3.1. Collection of GPS speed control checking devices During Administrative Checks.

Elektrénai Culture Center, Draugystés st. 2, Elektrénai. Date: 9<sup>th</sup> of September, 2022 (Friday); Time: 7:00 – 10:00.

## 9.3.2. Rally Safety Tracking system.

Organiser will provide a rally safety tracking system, which has to be used during reconnaissance in the reconnaissance car. If the system will not be used, it is a breach of the reconnaissance regulations. The progress of reconnaissance will be monitored via GPS system by rally officials. GPS data will be monitored also during liaisons. Evaluation of GPS data is within competence of Clerk of the Course. If reconnaissance vehicle is not equipped with a working tracking device, the crew will be penalized by Stewards. After reconnaissance, crews have to re-install the tracking device to the rally car.

## 9.3.3.

Each device has the unique serial number, that is assigned to a crew. During the competition, rally HQ is following the position and speed of each crew. GPS tracking device is connected with control centre, that gathers all the data. All data is also gathered in a device itself. Device has an autonomic voltage tension resource that is enough for all rally. Device "SOS" and "OK" buttons.

By pressing "SOS", crew members inform about an accident, informing that they need help asap. In this case, it is also mandatory to call the phone number written in the sticker on the GPS device. If the car stopped in SS due to an accident or technical issues, by pressing "OK" crew members inform rally HQ about car being stopped for less than 30 seconds period also informing that no additional assistance is needed.

Attention! If a crew has stopped in a SS for a period longer, than 30 seconds, even in the case, if crew is still trying to continue participation, crew members must press the button "OK". Crew phones must be turned on at all times (or



switched on within 60 seconds), that rally HQ would be able to gather the information about the situation.

## 9.3.4. Safety deposit.

Each crew must pay a deposit of 200 EUR upon receipt of GPS tracking device. Deposit will be refunded after proper return of tracking device after TC 11A In the Park Fermé. In case of retirement GPS tracking device must be returned to Rally HQ until 10<sup>th</sup> of September, 2022 (Saturday) 22:00 at the latest.

## 9.4. RECONNAISSANCE TIME SCHEDULE:

Reconnaissance time schedule is given in Appendix 2.

## 9.5. RECONNAISSANCE RULES:

Reconnaissance will be organized in compliance with T-2022 Art.35 and these Regulations.

## 9.5.1 Restriction of reconnaissance.

Any driver, or co-driver, or any other team member who has entered or intends to enter the rally and who wishes to drive on any road which is or might be used as a Special Stage in the rally after publication of Supplementary Regulations, may only do so after he has obtained the written permission from the Organiser. This shall not apply when the person is known to live along the specific road. Failure to respect this rule shall result in driver being reported to the Stewards.

## 9.5.2. Number of persons on board.

During each passage through a Special Stage, a maximum of 2 persons are permitted in the car. Third individual could be in a car if only he has a permission of Clerk of the Course. This individual must have LASF or any other ASN issued annual licence.

## 9.5.3. Number of passages.

A maximum 2 passages over each Special Stages is permitted during reconnaissance. Special Stages run twice are considered to be one Special Stage.

## 9.5.4. Speeding.



Speeding will be penalized according Art.34.2.2. of T-2022.

## X. ADMINISTRATIVE CHECKS.

## **10.1. DOCUMENTS TO BE PRESENTED:**

At Administrative Checks the following documents will be checked and entry form details verified:

- Competitor's licence;
- Driver and Co-driver competition licences;
- Driver and Co-driver valid driving licences;
- ASN authorisation (where applicable);
- Fully completed and signed entry form;
- Medical certificate of aptitude (F 068/a or "Medical certificate of aptitude" FIA ISC, appendix Valid personal accident insurance of non-EU drivers;
- Valid Insurance for drivers from Non-EU countries;

In order to speed up administrative checks crews are asked to send scanned licenses, authorisations and medical certificates to the organiser via e-mail: info@rallyelektrenai.lt.

## 10.2. TIMETABLE:

Administrative checks will take place at the same time with Reconnaissance registration as follows:

Being late to Administrative Checks will be penalized by 30 eur for each 10 min being late. At least one member of the crew must come to the Administrative Checks.

## XI. SCRUTINEERING, MARKING AND SEALING.

## **11.1. LOCATION AND SCHEDULE:**

9<sup>th</sup> of September, 2022 (Friday) 9:00 – 15:00. For LARC and LARSC crews; 10<sup>th</sup> of September, 2022 (Saturday) 7:00 – 9:00 only LARSC crews.



Location: Draugystės st., Elektrėnai, next to Service Park. Coordinates: 54.784974, 24.670591

The detailed timetable for pre-rally scrutineering will be published in a Bulletin. Any crew taking part in the rally, or their representative must arrive at the Scrutineering and present the car in accordance with the timetable to be issued in a Bulletin. Any lateness entering to pre-rally Scrutineering area will be fined by 30 EUR for each 10 minutes delayed. Driver and Co-driver are not required to be present during Scrutineering. Documents to be presented during Scrutineering:

- Valid vehicle insurance policy ("Green card");
- Vehicle registration documents;
- Vehicle FIA technical passport, when it's applicable;
- Vehicle ASN technical passport, when it's applicable;
- Fully and correctly filled Safety Equipment declaration;

## 11.2. MUDGUARDS:

Transversal mudguards are not mandatory.

## 11.3. WINDOWS:

The use of silvered or tinted films is authorized on side windows and rear windows only (in conformity with Appendix J Article 253-11).

## **11.4. DRIVERS' SAFETY EQUIPMENT:**

During scrutineering all items of protective clothing are going to be checked, including underwear, helmets and FIA approved head restraint (FHR). Compliance with Appendix L Chapter III will be checked.

## 11.5. NOISE LEVEL:

The maximum noise level must not exceed 103 dB for an engine rotation speed of 3500 rpm.

## **11.6. INSTALATION OF SAFETY TRACKING SYSTEM:**

11.6.1. All Competitors must make provision in their cars for the installation of the Safety Tracking System. Systems will be issued at the Administrative Checks. All further details will be given during presentation to each crew.



11.6.2. Competitors must have installed the speed control and safety tracking devices in reconnaissance cars before reconnaissance starts. The system must be re-installed to the rally cars by the crews and must be shown to the Scrutineers before TC0.

11.6.3. Any attempt to tamper with, to manipulate or to interfere with the tracking device fitted to the competition car or any device that fails to record a trace due to external interference will be reported to the Stewards who may impose a penalty up to disqualification.

## XII. OTHER PROCEDURES.

## 12.1. CEREMONIAL OPENING PROCEDURE AND ORDER:

Ceremonial rally opening will take place on 9<sup>th</sup> of September, 2022 (Friday) 16:30 in Draugystes st., Elektrenai, next to the stage and service park.

All drivers and co-drivers are required to gather before the stage next to TCO for opening ceremonies and national anthems. After the opening ceremonies crews will drive to TCO and further to SS1. There is no holding area before TCO.

The start list for the 1st Section of 1st Leg will be published on 9<sup>th</sup> of September, 2022 (Friday) 16:00.

SS1 LARC crews will start each 2 minutes. Section 2, all crews will start with 1 minute interval.

After TC4B the Park Ferme procedure is mandatory. Vehicle could be presented by team representatives / mechanics.

## **12.2. FINISH PROCEDURE:**

After the final Special Stage all crews will continue to the Park Fermé TC 12A – finish of the rally. Crews may dismount GPS tracking devises in the Park Fermé. Cars to be expected for Final Scrutineering will be collected and guided by the officials from the Park Fermé. Cars may be removed from final Park Fermé when Stewards authorise its opening.

Prizes for all Competitors/crews will be awarded on the stage, next to the Service Park. Prize-giving procedure will start at 10<sup>th</sup> of September, 2022 (Saturday) 21:00. Cars must remain in Park Ferme until Stewards decision to open Park Ferme. If all the procedures are happening according to the schedule, cars may be removed on 10<sup>th</sup> of September, 2022 (Saturday), 20:45.



## **12.3. PERMITTED EARLY CHECK-IN:**

Crews are authorised to check-in early without time penalty at:

- TC 3A (entering the Service IN);
- TC 3B (entering the Park Fermé);
- TC 7B (entering the regroup zone);
- TC 11A (entering the final Park Fermé).

## **12.4. START PROCEDURE FOR SPECIAL STAGES:**

Start procedure for special Stages will be as follows:

On the start position crew stops when instructed by marshals;

When the start marshal confirms that the car is on the right start position -40 cm before electronically controlled start line the car must stay immovable till start moment and the crew must visually follow the time and lights on the monitor.

30 seconds before start marshal hands the Time Card to Co-driver;

The last five seconds are marked by 5 red lights and a green light. The first red light lights up on  $55^{\text{th}}$  second, second – on  $56^{\text{th}}$  second and so on. On the time of exact minute red light go out and green light lights up.

If the car crosses the beam before the green light lights up "FALSE" will be shown automatically on the monitor. False-start will be penalized according T-2022 Art.48.6.

The start marshal makes the final decision about false-start and notes this in the start report.

In case of start system malfunction the start will be given by marshals according to T-2022 Art.48.3.

Upon retiring, a crew must hand in its time card either to a marshal at a TC or to the sweeping car.

## 12.6. OFFICIAL TIME USED DURING THE RALLY:

During all rally, official time is considered the Eastern European summer time (CET +2, UTC+3).

## 12.7. REGROUPING:

There are two regroupings planned, in connection to start order changes, acting according to results after SS 3 and SS 7, as well after SS 5 (LARSC). It is possible to restart in rally after TC 4C for LARC participants and after TC 8C for LARSC participants ("Rally 2" rule).

## **12.8. RETIRING BECAUSE OF AN ACCIDENT:**

Retiring Competitors of LARC after an accident must submit their cars to the Chief Scrutineer Saulius Stanaitis +370-687-31023 for inspection of damage. Failure to do so will result in fines.

Service regulations will be in accordance with T-2022.

Service zone is located at Draugystes st. in Elektrenai. Surface: tarmac.



Parc Ferme, Regrouping area and Refuelling zone are situated in connection with Service zone.

Service zone opens on 9<sup>th</sup> of September, 2022 (Friday) 08:30 and closes 10<sup>th</sup> of September, 2022 (Saturday) 23:00.

There is no flexi-service, remote service zone or remote refuelling zone during the competition.

12.9.1. If Competitor has multiple competition cars to be located together in service Park, the application for consecutive Service Areas must reach the Organiser by  $2^{nd}$  of September, 2022 (Friday) 18:00 at the latest. In agreement with the Organiser, Competitors may order additional service space with the price up to 10 EUR/m2, in case there is still additional space available in the Service Park.

12.9.2. In Service Park, all crews are obliged to have a liquid-proof tarp of minimum 3x5 m under competition cars. Drilling or any other damages to the surface of the Service Park have to be avoided. Teams must bring weights for fixing their tents. Each Competitor is liable for the damages to the Service Zone allocated to them. After the rally, the Service Park has to be handed over in tidy condition. The crews are responsible for the removal of their waste and sewage.

12.9.3. **One service vehicle** per all competitors is allowed in Service Park. Vehicles must be clearly identified by a "SERVICE" sticker issued by the Organiser and affixed on the windscreen.

Team/VIP plates (stickers) must be affixed to the upper side of the windscreen on the right (passenger) side. Removal of the sticker is prohibited until the end of the rally.

Reconnaissance cars and VIP vehicles are not allowed to enter Service Park.

12.9.4. Competitors who fail to comply with Service Park rules are subject to a penalty starting from 50 EUR up to disqualification.

## **12.10. PASSES TO THE EVENT:**

Organiser commits to ensure that all holders of LASF licenses (entrants, drivers, marshals, and seniors), members of LASF administration, members of LASF



Council, supporters may be able to get into the event by submitting a valid LASF certificate (plastic card) with a personal photograph.

XIV. PRIZES.

## 14.1. ORGANISER'S PRIZES:

Winners of "Rally Elektrenai by aromáma 2022" – Rally Challenger Cup (winner can be the crew who tires are used according to T-2022 regulations' article no. 13).

Best three crews in "Rally Elektrenai by aromáma 2022" in every group according to the Paragraph 4.3.3.1. and 4.3.3.2. of these Regulations.

## 14.1.1. Special prizes.

A list of Special Prizes will be published on the Official Notice Board before the start of the rally.

## 14.2. PRIZE-GIVING:

Prize-giving will take place on 10<sup>th</sup> of September, 2022 (Saturday) 21:00 at Podium place, in Elektrenai Amphitheatre, Draugystes st., Elektrenai.

Prizes for all crews will be awarded on the Podium.



In case prize-giving will take place before the publication of final classification, the ownership of prizes handed to the winners will be confirmed after the Final Classification.

All athletes must wear the racing suits. All rally LARC participants must wear "Pirelli" caps. They will be delivered by "Pirelli" representatives (T-2022 regulations article 11.1.3.).

If participants are not following this regulation they might be penalized.

The ownership of the prizes provided is confirmed after final results are published.

## XV. FINAL CHECKS.

## 15.1. FINAL CHECKS:

Location: Sabališkių st. 1L, Elektrėnai.

Date:  $10^{th}$  of September, 2022 (Saturday) right after the finish of the rally at TC12A.

Competitors who will be selected for the final Scrutineering (Stewards' decision) are requested to provide proper equipment (including all sealed spare parts) and mechanics at the Final Scrutineering venue. Each selected car will be driven to Final Scrutineering by a designated member of the team (who must be present at the finish), and accompanied by an official.

In case of a protest, the said car will be checked at the same venue.

## **15.2. PROTEST DEPOSIT FEE:**

Protests are made according to LASC article no. 13. The protest fee is  $\leq$ 150 for LARC competitors (LARC Regulations 10.2.). If a protest requires the dismantling and re-assembly of different parts of the car, the claimant must pay an additional deposit (LARC article 10.4). Protest fee for LARSC – 100 eur (LARSC regulations article no. 10.2)

## **15.3. APPEAL DEPOSIT FEE.**

Appeal is made according LASC article 15.

The sum for a Lithuanian national appeal deposit (ASN) is 1000 EUR.
